


DR. JEAN AUGUSTINE

Born on September 9, 1937, in St. George's, Grenada, she is an influential Canadian politician and advocate for social justice. Immigrating to Canada in 1960, she quickly gained recognition in education and politics. She graduated from the University of Toronto with both a Bachelor's and a Master's degree in education. She began her career as a teacher and later became a principal with the Metropolitan Separate School Board in Toronto. She played a pivotal role in organizing the Caribana Festival and was actively involved in the National Congress of Black Women of Canada and the Urban Alliance on Race Relations. In 1993, she made history as the first Black woman elected to the Canadian House of Commons, representing Etobicoke-Lakeshore until 2006. During her tenure, she held significant positions, including Parliamentary Secretary, Minister of State for Multiculturalism and Status of Women, and Chair of parliamentary committees. Her accomplishments include establishing February as Black History Month and supporting the construction of the Famous Five Monument. After her political career, she served as the Ontario Commissioner for Equality (2007-2015) and is now engaged in social advocacy as a patron of non-profit organizations.

GISELLE DREW WALSH

A dynamic leader, motivational speaker, and advocate with a powerful story of resilience and service. As Mrs. Universe Canada '24/'25, she represented Canada at the Mrs. Universe competition in South Korea, where her outfits honored various eras of the Canadian Military, including a handmade National Costume adorned with poppies from veterans. She placed in the top 25 out of 110 delegates, marking a significant achievement for Canada. Giselle dedicates her platform to empowering individuals to overcome adversity, promote mental health awareness, and inspire leadership. Her military background, focused on education and training, instilled in her a passion for resilience and empowerment. This unique blend of military discipline and personal experience makes her a sought-after speaker on leadership, mental health, and women's empowerment, resonating with diverse audiences, from veterans to corporate teams. As Board Secretary for Valour in the Presence of the Enemy and a director at CIMVHR, she champions veterans' needs and advocates for better mental health resources. Additionally, she hosts the Breaking Dress Regs podcast, sharing stories of resilience and leadership that inspire change. Giselle's speaking engagements focus on personal growth, community power, and leadership in adversity. Through her authenticity and storytelling, she inspires action and fosters compassion. 


MAGGIE HABIEDA

served as Chair for over six years, and other boards including Delta Family Resource Centre and DYLOTT. Through these roles, she mentored over 60 individuals, many of whom have become lawyers, CEOs, and entrepreneurs. Dauna's leadership also encompasses the co-founding of the 100 Accomplished Black Canadian Women project, celebrating the achievements of 500 Black Canadian women through publications, Fireside Chats, annual symposiums, and biennial book launches and award ceremonies. In 2024, she made history as the first Black President-Elect of the Rotary Club of Toronto, Canada's largest Rotary Club, founded over 115 years ago. Among her recent philanthropic endeavors, Dauna orchestrated the donation of 40.000 syringes to diabetics in St. Kitts who could not afford them and spearheaded a sewing project to create menstrual pads for homeless women in the Dominican Republic. ORDER OF ST. STANISLAS

Order of Saint Stanislas is a Polish order of knighthood that was instituted in 1765 by the last Polish King before the partitions of the country, King Stanislaw August Poniatowski. It is deeply grounded in the history of the final years of the Kingdom of Poland before its dissolution (a Commonwealth Kingdom which included Polish Lithuania, Ukraine and Belarus), and it is a symbol of Polish heritage and culture. The institution of Order came with the development of Bishop-Martyr's cult, a defender of faith and those who suffer. After the 1830 Uprising by Russian tsars, it was incorporated into the honors system of the Russian Empire, and by independence, the Second Republic of Poland replaced it with Order of the Rebirth of Poland. However, by the 9th of July 1979, at the 900th Anniversary of the death of the Marty of Saint Stanislas, Order of Saint Stanislas was reinstituted by the President of Republic of Poland and Polish Government (in Exile) and since 1990 Order become an independent world-wide distinction.

He has worked with the Belgian group CBR, Heidelberg Cement in Germany, and the Ministry of Economy, where he led

the Departments of Oil and Mining. As Deputy Minister of Economy during the Polish EU Presidency, he was responsible for the energy, fuel, and mining sectors. Upholding family traditions, he grew up in an environment that valued science and the cultivation of patriotic attitudes. Through many years of running a business in automotive electromechanics, he trained hundreds of young people. He has always financially supported those eager to learn and acquire new skills. Extensive global travels have also allowed him to aid the poor and needy. In Poland, he actively participates in various charitable auctions.





MATEUSZ MALEK (CStS) Commander's Cross, Order of StS with Crown

Born on April 23, 1978, he is a co-founder and partner of XL LOGISTICS, an international logistics company that has been thriving for 18 years. He is a devoted husband and father of two teenage sons. Mateusz holds a Master's degree in international Transport and Freight Forwarding from the University of Economics in Katowice (2003), a postgraduate diploma in Logistics from the Institute of Logistics and Warehousing (EAN), and an MBA in Small and Medium Enterprises from WSB University (2023). Mateusz continuously expands his knowledge through various training programs in modern technologies,

She began her career as a teacher and later became a principal with the Metropolitan Separate School Board in Toronto. She played a pivotal role in organizing the Caribana Festival and was actively involved in the National Congress of Black Women of Canada and the Urban Alliance on Race Relations. In 1993, she



made history as the first Black woman elected to the Canadian House of Commons, representing Etobicoke—Lakeshore until 2006. During her tenure, she held significant positions, including Parliamentary Secretary, Minister of State for Multiculturalism and Status of Women, and Chair of parliamentary committees. Her accomplishments include establishing February as Black History Month and supporting the construction of the Famous Five Monument. After her political career, she served as the Ontario Commissioner for Equality (2007-2015) and is now engaged in social advocacy as a patron of non-profit organizations.





EVELYN BAILEY Knight's Cross, Order of Sts

Evelyn is a first-generation Chilean Canadian born in Toronto, has built a remarkable career in the arts, shaped by her diverse heritage and creative upbringing. Raised by parents who fled Chile during the Pinochet dictatorship, Evelyn's Jamaican ancestry adds depth to her cultural identity, reflected in her surname. From an early age, she pursued classical fine arts and later earned a degree in Art of Animation, mastering traditional and digital techniques. Her observational drawing skills, honed during subway rides, led to the creation of a notable short film, opening doors in film and production. After a tragic fire destroyed her family's home in

Chile, Evelyn returned to Canada, becoming a mother to twin boys in 2016. Undeterred by personal challenges, she founded Evalution Workshop in 2017, empowering others to heal through art. Evelyn's influence extends beyond her art; she plays a key role in Niagara Falls' cultural scene, participating in the Artists Discovery Program and the Arts and Culture Committee. As Creative Director of the award-winning Light Show in Cambridge and through her company Enlightened Art Inc., launched in 2021, Evelyn continues to blend technology and art, inspiring others to embrace creativity and resilience.

DAUNA JONES-SIMMONDS (DCStS)

Knight's Cross, Order of StS

Dauna, recognized as one of the 100 most influential Black individuals in Canada, is a pioneer in social service and leadership and a recipient of the Brilliant Minded Women Award. Hailing from St. Kitts, where she was the thirteenth of fourteen children, she displayed caregiving abilities from a young age. After moving to Nevis and then returning to St. Kitts, she gained a reputation as a community caregiver and an active participant in sports and social activities. In Canada, she co-founded JOIN, an organization supporting the employment of individuals with disabilities, and served as Chair of ACCES Employment. She was involved with



the Delta Family Resource Centre and DYLOTT, preparing over 60 individuals for leadership roles. She also co-founded the 100 Outstanding Black Canadian Women project, which honors successful professional women. In 2024, she will become the first Black President-Elect of the Rotary Club of Toronto, the largest Rotary Club in Canada. Dauna enjoys spending time with her grandchildren and family, traveling to over 40 countries, and is passionate about Caribbean cuisine.





CARMELA LIPAROTI (DCStS) Knight's Cross, Order of StS

Born in Buenos Aires, immigrated to Canada at seven. Settling in Toronto, she grew up embracing her Nipissing Algonquin Métis heritage alongside her Italian roots. Her studies in languages at York University enriched her ability to work with diverse communities. Initially, she worked in social services in Mississauga, and later emerged as a leader as President of the Mississauga Italian Canadian Benevolent Association (MICBA). In this role, she initiated projects such as the Forum Italia Non-Profit Housing Corporation and Villa Forum Long Term Care Home. Carmela is also active in charitable endeavors, supporting

Sunshine Dreams for Kids and projects in Tanzania. Her commitment has been recognized with numerous awards, including the Diamond Jubilee Medal of Queen Elizabeth II and the June Callwood Outstanding Achievement Award for Voluntarism in Ontario. MARGARET MAYE (DCStS)

Knight's Cross, Order of StS

Margaret Maye embodies resilience and compassion through her community service, artistic work, and civic engagement. Raised in a spirit of empathy and solidarity, her life was dramatically altered by her son's epilepsy diagnosis. In 1997, she co-founded the Epilepsy Cure Initiative (ECI), focusing on public education, dispelling myths, and improving treatments. ECI organized significant events such as the International Seminar on Medical Nutritional Therapies in Epilepsy and influenced legislative improvements in Canada, including the establishment of Epilepsy Awareness Days at Queen's Park and Parliament Hill. Margaret's



impact extends to the arts, where she promotes cultural diversity and understanding. Her contributions have been recognized with honors such as Order of Merit from the Ministry of Culture of the Republic of Poland and the Silver Award from the Polish-Canadian Congress in 2007. She also received the Volunteer Award and the Lifetime Achievement Award from the Brilliant Minded Woman Foundation. Supported by her family—partner Gary, son Tomek, daughter-in-law Małgosia, and grandson Daniel—Margaret continues her advocacy for epilepsy awareness and the arts. Their support is crucial to her ongoing success and commitment to improving lives and fostering cultural enrichment.

Officer's Cross, Order of StS

Since its founding in 1979 by Father Michael Smith, OMI, and a dedicated board, the Kopernik Residence has served Polish seniors in the Roncesvalles neighborhood of Toronto. Initially established to support those affected by the war and deportation to Siberia, the Residence provides a culturally enriched environment integrating physical, emotional, and spiritual care. Over the past 45 years, it has expanded to accommodate over 400 seniors, offering both assisted living and long-term care. As a non-profit organization, it funds its operations through government grants and community donations. Celebrating its 45th anniversary in 2024, the Residence has organized events such as the Galaxy Ball and the revival of the annual Father Michael Smith Golf Tournament. It remains actively engaged in the community, participating in events like the Roncesvalles Polish Festival, while steadfastly upholding its mission of compassion, respect, and cultural preservation for Toronto's aging Polish population.
